The promotees who have been promoted to the post of Assistant through DPC as well as LDCE have the option to accept the promotion from either of the mode of promotion and the option once exercised will be final. The declaration by the official regarding their acceptance / refusal of the promotion offered, shall be communicated to this office by 30.10.2025.

The officials, who are working in the cadre of UDC, are to be relieved as per this order to assume charge on promotion; their promotion will take effect from the date on which they assume charge as Assistant on the basis of this order.

On promotion the above officials will draw the initial pay in the Pay Level - 6 of Pay Matrix as per 7<sup>th</sup> CPC or their present pay, whichever is higher, pending fixation of pay, wherever applicable. The officials who availed the benefit of pay fixation in the same Pay Level on financial upgradation under ACP / MACP Scheme will, however, not get any benefit of pay fixation on his promotion on regular basis.

Officials presently posted at Branch Offices as UDC - Cashier will continue to draw cash handling allowance on posting as Assistant - Cashier.

The regular promotion of the above officials has been made in accordance with the terms and condition of Service as are applicable to the similar category of employees as contained in the ESI Corporation (Staff and Conditions of Service)Regulation, 2023, as amended.

The selection of candidates as per the above result is provisional and subject to verification of their conduct during the course of LDCE held on 05.07.2025. In case, any selected candidate is found other use of means during the exam as per CCTV footage, etc. the candidature / selection of such candidate will be liable for cancellation without any prejudice to initiation of departmental proceedings against him / her. Similarly, candidates found guilty of any misconduct during the course of LDCE on 05.07.2025 will also be liable to be proceeded upon through departmental action.

The above promotion order is also subject to to Court / CAT case, if any, in the matter of seniority, etc.

The officials, who are ordered for regular promotion, may exercise option, if they so desire, for fixation of pay from the date of their next increment, in terms of FR 22(1)(a)1) para 2 within one month from the date of their joining the post on promotion.

The officials who are on leave may be directed to report to their respective post as ordered after expiry of leave.

Aforesaid officials for the time being are promoted at the same place of posting and transfer orders, if any, will be issued in due course.

Necessary joining report / acceptance of promotion / relieving order etc may be forwarded to Deputy Director (Administration Branch), Regional Office Ahmedabad in due course.
