- (2) The aforesaid financial upgradation under MACP Scheme shall, however, be subject to the terms and conditions as laid down in the DOPT, OM dated 19-5-2009, 16-11-2009, 9-9-2010 & 22-10-2019 and Headquarters Office letter dated 11/09/2015 and as clarified by DOPT/ HQ's office from time to time. Further, in case the employee is holding higher post on purely ad hoc basis before the date of recommendation of financial upgradation, the matter, may be regulated as per point No. 25 of Annexure -! of DOPT, OM dated 22.10.2019.
- (3) They shall exercise their option for fixation within one month from the date of issue of this order as per saving clause under FR22(I)(a)(1).
- (4) No stepping up of Pay in the Pay Band or Grade Pay would be admissible with regard to junior getting more Pay than the senior on account of Pay Fixation under ACP / MACP Scheme.
- (5) On up-gradation under the MACP Scheme, pay of an employee shall be fixed as per para 4 to 7 of Annexure-I DOPT OM dated 22.10. 2019 after confirmation of the details of service records from respective Service Book. Discrepancy, if any, may be immediately brought to the notice of Regional Office Maharashtra.
